You have the right to control whether we share some of your personal information. Please read the following information carefully before you make your choices below.

YOUR RIGHTS

You have the right to restrict the sharing of personal and financial information with our non-affiliates (outside companies that we do business with).

Nothing in this form prohibits the sharing of information necessary for us to follow the law, as permitted by law, or to give you the best service on your accounts with us. This includes sending you information about other products or services.

YOUR CHOICE

Restrict information sharing with companies we own or control (affiliates):

Monterra Credit Union (Monterra) does not own or control any affiliates.

Restrict information sharing with non-affiliates (companies we do business with to provide financial products and services):

Unless you indicate "NO," we may share personal and financial information about you with outside companies we contract with to provide financial products and services to you.

NO, please do not share personal and financial information with outside companies you contract with to provide financial products and services.

You may make your privacy choice at any time. Your choice as indicated within this form will remain unless you state otherwise. However, if we do not hear from you, we may share some of your information with non-affiliates (companies with whom we do business with to provide financial products and services).

| WHY? | Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do. | |

| <p>How does Monterra Credit Union protect my personal information?</p> | <p>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.</p> |
| <p>How does Monterra Credit Union collect my personal information?</p> | <p>We collect your personal information, for example when you</p> <ul style="list-style-type: none"> - open an account or deposit money - provide account information or apply for a loan - use your credit or debit card <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p> |
| <p>Why can't I limit all sharing?</p> | <p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> - sharing for affiliates' everyday business purposes - information about your creditworthiness - affiliates from using your information to market to you - sharing for nonaffiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</p> |

| <p>Affiliates</p> | <p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> - <i>Monterra Credit Union has no affiliates</i> |
| <p>Nonaffiliates</p> | <p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> - <i>Nonaffiliates we share with can include companies such as retailers and membership clubs.</i> |
| <p>Joint marketing</p> | <p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> - <i>Our joint marketing partners include categories of companies such as insurance providers and financial advisors.</i> |

OTHER IMPORTANT INFORMATION

California law provides that a consumer has the right to control the sharing of personal and financial information with outside companies the financial institution contracts with to provide financial products and services.
